BARP OPENS NEW PMES SITE

BARP Foundation opened a new site at Pines Park, LM 4 La Trinidad, Benguet for its Monthly Pre-Membership Education Seminar. This is being initiated to augment its regular PMS held at the SSS Canteen every 1st Saturday of the Month. This is done in response to requests from people desirous to join the Foundation.

Last February 12, 2011, the first PMES activity at Pines Park was conducted with initial 27 applicants coordinated by Aida Patot, a barangay coordinator at Atok, Benguet, who made the arrangement with Josie A. Kawi, President/Gen. Manager of the Topmake International Manpower Services under POEA-054-LB-022103-R. The activity was considered a success and so a similar PMES will take place in the same venue again.

Along this line, again due to frequent requests from various individuals for the Foundation to conduct PMES also in Tuba, Sablan, Itogon, La Trinidad, Tublay and other places, the organization is considering conducting similar activity in these places. This plan is based on reaching and spreading out its vision far and near.

A PMES will be conducted again at Pines Park, La Trinidad, Benguet on March 26, 2011 at 9:00 A.M. Starting April 9, 2011, a PMES will be held regularly there while the PMES at the SSS Canteen goes on as usual.

Five new Board members will be elected this year by the General membership. The BMC management in-charge of this activity is now calling those members who may be interested to run for the Board to file. Deadline for filing certificate of candidacy will be on March 11, 2011. MOUNT KABUNIAN SCENERY

Have you reached the foot of the enchanted Mount Kabunian in Central Bakun? The BARP Team almost did the mission as the assembly hall is just a kilometer away. The team composed of Trustees Menchita Damoslog, Juanita Ibis, Bial Palaez, Cris Buli-e, our pilot and Danny Camodag, Bakun Municipal Coordinator, were authorized by BARP Foundation Federico A. Balanag to conduct a Pre-Membership Educational Seminar (PMES) in Central Bakun, the original seat of Municipal Government. The mission was in response to the request of elders for residents desiring to join our BARP Foundation.

Trustee Ibis described the trip beautiful and enjoyable. Just imagine the winding, zigzagging, and the up and down steep dirt and partly paved road from Sinipsip junction to Central Bakun. The group were not at all bothered with the condition of the 32 kilometers provincial road because they enjoyed the panoramic and attractive view.

Not aware of the distance and difficult road condition the team miscalculated their timing. They arrived in Central Bakun at 1:00 P.M. instead of 10:00 A.M. which means they were behind three hours in their schedule. Anyway, our expected audience composed of Barangay Officials, Senior Citizens, Cooperative and PTCA officials and members did not disperse. Instead they prepared a welcome program specially our late lunch consisting of beef, chicken pinicpican blended with kintoman rice plus native wine and delicacies prepared and served at the new Barangay Hall.

The afternoon program was held infront of the Barangay Hall adjacent to the multi-purpose cooperative building. Before the forum on PMES an opening portion with warm and friendly welcome remarks from the Central Bakun senior residents led by Punong Barangay Mr. Flores L. Tamiday and followed alternately from others.

Centerpiece of the PMES include the benefits that a member of good standing normally receive from our BARP Foundation, his rights, duties and obligations. This portion was ably handled by Vice President for Education and Membership Bial A. Palaez. He further explained why many people joined BARP. They come from the City of Baguio, Benguet Province, the Cordillera Region, many from the lowland regions including some from abroad. BARP on record has 16,000 registered members with 11,000 active while the inactive are currently updating and reactivating their membership in accordance with BARP rules and policies.


Trustee Menchita Damoslog, Vice President for Chapter discussed the DIWA programs and project assistance including scholarship for qualified and deserving children of BARP members. Trustee Juanita Ibis, the Foundation PRO concentrated on the services accorded to BARP members of good standing. She, being a doctor of education, discussed discipline, moral values and honesty in the foundation. Both contributed in answering and explaining clarifications to questions asked from the audience.

As we noticed the thick clouds descending from the mountain top and cliffs down to the fields, the group prepared to move early for home sweet home for fear that it will rain in the afternoon making the dusty road slippery.

An instant query about the enchanted Mount Kabunian and Doligen as written in the tourism brochure. Mr. Palaez who has previous knowledge on the Benguet Tourism took time to relate the legend for confirmation by the Bakun elders and the notes runs - many people from various places come to visit Mount Kabunian. When tired and at rest, they are automatically serve food by the intangible mountain spirits. This legendary practice has been going on for centuries and one day a hunter named Dolegen who came from far north tired and on rest at the rocky center of Mount Kabunian. Suddenly, he was served food. After his meal he carted away the utensils placing in his hunters bag the plate, cup and spoon. Angered, the mountain spirits picked up Dolegen and pasted him in the rocks with his penis organ through which spring water passes thru at public view. After this juncture, the Bakun elders were full of smiles which is an indication of confirmation on the enchanted Mount Kabunian legend.

And before our departure for home the Bakun elders reiterated their invitation for another PMES next year, a much bigger one with more BARP Trustees lead by President Federico A. Balanag. They are determined to increase their present 250 Bakun membership with BARP.-Juanita Ibis

CREDIT COMMITTEE MONTHLY REPORT

The Credit Committee reports that it was able to serve sixty-nine (69) borrowers for their needed loans. The total loan released was **Php2**, **181**,**728**.**00** .

Breakdown of loans from January 1 to January 31 was as follows:

- 1. Capital for business & Commercial ventures Boats management, sari-sari store & wagwagwan)—22 (Number of Borrowers)—3.13%
- 2. Construction & repair of houses —16 (Number of Borrowers) —4.31%
- 3. Agricultural & backyard livelihood (Vegetables, poultry, piggery, rice)—14 (Number of Borrowers)—4.92%
- 4. Personal use, medicines (Emergency)—12 (Number of Borrowers) —5.75%
- 5. Travel expenses, tuition fees (Providential)—5 (Number of Borrowers) —13.8%

The various productive and provident loans offered to members in moments of financial need provided them with the basics of food and shelter. We have likewise given the families the ease and support in their daily lives & tuition for the children.

We look forward to an increase of members (as we did some verbal campaign) and asset growth, with the kind of strong leadership that we have now, the integrity, professionalism & respect as they are all service-conscious and value-oriented.
